Description of the map

The map shows the proposed Prohibition of Waiting zone on Pitmaston Road, Middle Road, Great House Road and Bedwardine Road, **Worcester**

<u>Pitmaston Road (North side)</u>: from its junction with Middle Road for a distance of 4 metres in both an easterly and westerly direction.

<u>Middle Road (Both sides)</u>: from its junction with Pitmaston Road for a distance of 6 metres in a northerly direction.

<u>Great House Road</u> (South side): from its junction with Bedwardine Road for a distance of 5 metres in an easterly direction and 9.5 metres in a westerly direction.

<u>Bedwardine Road (Both sides):</u> from its junction with Great House Road for a distance of 5.5 metres in a southerly direction.
